*Beskrywing:*

16. THE HISTORIC RONWE HOMESTEAD AT HUGUENOT, PAARL DISTRICT

*Description:*

The historic Ronwe Homestead, consisting of the Victorian farmhouse, the barn and the ring-wall, together with three (3) metres of surrounding land, situate on certain piece of land in the Division of Paarl, being the remainder of the farm Ronwe 851.

17. THE HISTORIC SANDSTONE CHAPEL AT TOKAI, CAPE TOWN

*Description:*

The fenced area with the historic sandstone chapel thereon, in extent 1 244 square metres, situate on a certain piece of land at Constantia, Cape Division, being a portion of the farm Tokai (now known as Erf 3346, Tokai).
