**43. THE CITY HALL, DARLING STREET, CAPE TOWN**

*Description:*

The exterior of the City Hall, bordered by Darling, Parade, Longmarket and Corporation Streets, in its entirety, including the external walls and windows therein, the roof, the clock tower and the entrance balcony and steps, as well as, inside the building, the main entrance vestibule and marble stairway to the first and second floors, the Mayor's Parlour, the Grand Hall, the Council Chamber and its vestibule and the marble stairway leading to the gallery, the City Hall in its entirety being situated on unregistered State land vesting in the City Council of Cape Town and demarcated as the figure ABCDEFGH, in extent 4 852 square metres, on Diagram SG 12931-84, dated 17 April 1985, being Erf 4942, Cape Town, situate in Cape Town in the Municipality of Cape Town, Administrative District of the Cape, Province of the Cape of Good Hope. Copies of the diagram are filed in the offices of the City Council of Cape Town and the Surveyor-General in Cape Town and on File 3/K/C-T/16 in the Head Office of the National Monuments Council in Cape Town.

**44. THE HISTORIC THORNLEY HOMESTEAD ON THE FARM DUNDEE, AT TALANA HILL, DUNDEE**

*Description:*

The historic Thornley Homestead, consisting of the farmhouse together with 50 metres of the front garden as well as the outbuildings at the rear of the farmhouse, situated on a portion of the Remainder of Subdivision B of the farm Dundee 4339 (now known as the farm Thornley) in the County of Klip River, Province of Natal.

**45. THE EXTERNAL STRUCTURE AND FACADES OF THE JOHAN CARINUS ART CENTRE, KNOWN AS TRURO HOUSE, GRAHAMSTOWN**

*Description:*

The external structure and facades of the so-called Truro House, situated on the following erven:

(a) Certain piece of land, situate in the Municipality of Grahamstown, Division of Albany, being a section of erven 110 and 111, marked as Lot 2 of Erf 110, now known as Erf 3430, Grahamstown; and

(b) certain piece of ground, situate as above, being a section of erven 110 and 111, marked as Lot 3, being part of a section of Erf 111, now known as Erf 3429, Grahamstown.

**46. CONISTON HOUSE, COLESBERG**

*Description:*

The so-called Coniston House together with three (3) metres of land on both sides, as well as at the rear of the building, including that area of land in front of the house as far as the erf boundary, situated on the following erven:
