

9. DIE OU SPOORWEGSTASIEGEBOU, BELLAIR, DURBAN

Beskrywing:

Die Spoorwegstasiegebou, geleë op 'n gedeelte van sekere grond, synde Onderverdeling SAR 2 van Onderverdeling C van Onderverdeling S van die plaas Bellair 823, geleë in die stad Durban, County Durban, provinsie Natal.

10. CAMDEBOO HOUSE, RYNEVELDSTRAAT 4, HANOVER
