BYLAE

1. RHEINGOLDGEBOU, MARKSTRAAT, PIETERSBURG

Beskrywing:

Die eiendom bekend as die Resterende Gedeelte van Erf 18, met die Rheingoldgebou daarop, geleë in die dorp Pietersburg, Registrasieafdeling LS, Transvaal, en groot 1 475 (eenduisend vierhonderd vyf-en-sewentig) vierkante meter.

2. DIE OPSTAL VAN DIE PLAAS HAZENJACHT, DISTRIK OUDTSHOORN

Beskrywing:

Die Hazenjacht-opstal, tesame met 20 meter grond daaromheen, geleë op sekere afgeskaafte erfaggrond in die afdeling Oudtshoorn, synde Perseel 2 van Perseel 46B van die plaas Hazejagt, 'n gedeelte van Perseel 60A, 2, 4, 42, 8, 45A, 46B en 11 van die plaas Hazejagt en Perseel 60B van die plaas Brak Rivier [nou bekend as Gedeelte 14 (gedeelte van Gedeelte 21) van die plaas De Haasejagt 79, afdeling Oudtshoorn].

Transportakte 27391/1973, gedateer 21 September 1973 (par. 3).

3. SCHOONZICHT, HOOFWEG 204, KALKBAAI, KAAPSTAD

Beskrywing:

Die eiendom, met inbegrip van die laat-Victoriaanse dubbelverdiepingstrandhuis daarop, bestaande uit die volgende:

(i) Die resterende gedeelte van sekere stuk grond, geleë in die stad Kaapstad, Kaapse Afdeling, synde Perseel 5 (nou bekend as Erf 90090, Kaapstad te Kalkbaai), en groot 178 (eenhonderd agt-en-sewentig) vierkante meter; en

(ii) die resterende gedeelte van sekere stuk grond, geleë soos hierbo vermeld, synde Perseel 6 (nou bekend as Erf 90088, Kaapstad te Kalkbaai), en groot 678 (seshonderd agt-en-sewentig) vierkante meter.

DECLARATION OF PROPERTIES AS
NATIONAL MONUMENTS

By virtue of the powers vested in me by section 10 (1) of the War Graves and National Monuments Act, 1969 (Act 28 of 1969), I, Frederik Willem de Klerk, Minister of National Education, hereby declare the properties as fully described in the Annexure hereto, to be national monuments.

ANNEXURE

1. RHEINGOLD BUILDING, MARKET STREET, PIETERSBURG

Description:

The property known as the Remaining Extent of Erf 18, with the Rheingold Building thereon, situated in the Township of Pietersburg, Registration Division LS, Transvaal, in extent 1 475 (one thousand four hundred and seventy-five) square metres.

Deed of Transfer T4500/1985, dated 8 February 1985.

2. THE HOMESTEAD ON THE FARM HAZENJACHT, OUDTSHOORN DISTRICT

Description:

The Hazenjacht homestead, together with 20 metres of surrounding land, situate on certain redeemed quitrent land in the Division of Oudtshoorn, being Lot 2 of Lot 46B of the farm Hazejagt, a portion of Lots 60A, 2, 4, 42, 8, 45A, 46B and 11 of the farm Hazejagt and Lot 60B of the farm Brak River [now known as Portion 14 (a portion of Portion 21) of the farm De Haasejagt 79, Division of Oudtshoorn].

Deed of Transfer 27391/1973, dated 21 September 1973 (para. 3.).

3. SCHOONZICHT, 204 MAIN ROAD, KALK BAY, CAPE TOWN

Description:

The property, inclusive of the late Victorian double-storeyed beach house thereon, consisting of the following:

(i) The remaining extent of certain piece of land, situate in the City of Cape Town, Cape Division, being Lot 5 (now known as Erf 90090, Cape Town, at Kalk Bay), in extent 178 (one hundred and seventy-eight) square metres; and

(ii) the remaining extent of certain piece of land, situate as above, being Lot 6 (now known as Erf 90088, Cape Town at Kalk Bay), in extent 678 (six hundred and seventy-eight) square metres.
