

4. THE CEMETERY WITH THE CONCENTRATION CAMP GRAVES AND BRITISH WAR GRAVES THEREON, SITUATED ON THE TOWNLANDS OF WINBURG

*Description:*

The cemetery with the concentration camp graves and British war graves thereon, described as follows: The figure ABCD represents 4 631 square metres of land, being a certain portion of the Remainder of the farm Dorpsgronden Winburg 681, situate in the Administrative District of Winburg, Province of the Orange Free State, as shown on Surveyor's Diagram LG 685/1985, dated 6 September 1985, and filed in the Office of the Surveyor-General in Bloemfontein.

Deed of Transfer 48114/1876, dated 11 July 1876.

5. THE VICTORIAN DWELLING-HOUSE, 19 QUEEN STREET, LADISMITH

*Description:*

The property, inclusive of the late Victorian dwelling-house thereon, being Erf 214, Ladismith, situate in the Municipality and Division of Ladismith in extent one thousand four hundred and twenty-eight (1 428) square metres.

Deed of Transfer 58109/1983, dated 14 December 1983.

6. THE VREDENBURG HOUSE, ROSEBANK, CAPE TOWN

*Description:*

The property, inclusive of the so-called Vredenburg House thereon, being the Remainder of Erf 31652, Cape Town at Rosebank, situate in the City of Cape Town, Cape Division, in extent two thousand six hundred and thirty-three (2 633) square metres.

Deed of Transfer 11439/1984, dated 1 March 1984.

7. THE LADY LOCH BRIDGE, NEAR WELLINGTON

*Description:*

The so-called Lady Loch Bridge, situated on that portion of the road reserve of Divisional Council Main Road 6 (also known as the Brakfontein Road) over the Berg River and also on portions of the following properties:

- (i) Certain piece of partly freehold and partly redeemed quitrent land, situate in the Municipality of Wellington, Division of Paarl, being the remainder of Erf 50, Wellington.

Deed of Transfer 15464/1982, dated 30 April 1982.

- (ii) The remainder of Portion 1 of the farm Zandrifft 189, situate in the Division of Paarl.

Deed of Transfer 3219/1983, dated 25 November 1983.

8. THE OLD TOWN HALL AS WELL AS THE LEAPING FOUNTAIN IN FRONT OF THE BUILDING, CHURCH STREET, KROONSTAD

*Description:*

- (i) The property, inclusive of the old Town Hall thereon, being Erf 579, Kroonstadt, situate on the farm Dorpsgronden van Kroonstadt 460, in extent 1 637 (one thousand six hundred and seventy-three) square metres; and

- (ii) the leaping fountain, situate on a portion of the road reserve in front of the Old Town Hall, on the farm Dorpsgronden van Kroonstadt 460.

Deed of Transfer 460/1875, dated 11 October 1875.
