

8. GEORGE SHAW-HUIS, UTRECHT

Beskrywing:

Die eiendom met die sogenaamde George Shaw-huis daarop, synde Erf 246, dorp Utrecht, geleë in die dorpsgebied Utrecht, distrik Utrecht, provinsie Natal, en groot seweduisend eenhonderd vyf-en-veertig (7 145) vierkante meter.

9. ANGLIKAANSE KERKIE, VOORTREKSTRAAT, SWELLENDAM

Beskrywing:

Die eiendom met die ou Anglikaanse Kerkgebou-tjie bekend as St Luke's daarop, synde die Restant van Erf 1034, Swellendam, geleë in die munisipaliteit en administratiewe distrik Swellendam, en groot een-duisend driehonderd (1 300) vierkante meter.

10. ALMARDE-OPSTAL, SONSKYN, DISTRIK WORCESTER

12. VICTORIAANSE WOONHUIS, LANGLEYWEG, WYNBERG, KAAPSTAD

Beskrywing:

Die eiendom tesame met die Victoriaanse woonhuis daarop, synde die Restant van Erf 67076, Kaapstad te Wynberg, geleë in die stad Kaapstad, Kaapse Afdeling, en groot seshonderd-en-ses (606) vierkante meter.

13. NEDERDUITSE GEREFORMEERDE KERKGEBOU EN KERKKLOK, ADENDORP, DISTRIK GRAAFF-REINET

9. ANGLICAN CHURCH, VOORTREK STREET, SWELLENDAM

The property with the old Anglican Church building known as St Luke's thereon, being the Remainder of Erf 1034, Swellendam, situate in the Municipality and Administrative District of Swellendam, in extent one thousand three hundred (1 300) square metres.

10. ALMARDE HOMESTEAD, SONSKYN, IN THE WORCESTER DISTRICT

The historic Almarde homestead, consisting of all the buildings within the ring-wall, the ring-wall itself, and the nearby thatched cottage, situated on a portion of certain piece of r deemed quitrent land in the Division of Worcester, being the farm Sonskyn 299.

11. THE PALINGGAT HOMESTEAD AND THE PALING FOUNTAIN, PLATTE BOSCH, STILL BAY DISTRICT

Description:

The historic Palinggat homestead and the nearby paling fountain, each with 20 metres of surrounding land, situate on Portion 57 (a portion of Portion 56) of the farm Platte Bosch 485, situate in the Municipality of Still Bay, Division of Riversdale.

12. THE VICTORIAN DWELLING-HOUSE, LANGLEY ROAD, WYNBERG, CAPE TOWN

Description:

The property together with the Victorian dwelling-house thereon, being the Remainder of Erf 67076, Cape Town at Wynberg, situate in the City of Cape Town, Cape Division, in extent six hundred and six (606) square metres.

13. DUTCH REFORMED CHURCH BUILDING AND CHURCH BELL, ADENDORP, GRAAFF-REINET DISTRICT
