### VERKLARING VAN EIENDOMME TOT NASIONALE GEDENKWAARDIGHEDE

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op oorlogsgrafte en Nasionale Gedenkwaardigheede, 1969 (Wet 28 van 1969), verklaar ek, Frederik Willem de Klerk, Minister van Nasionale Opvoeding, hierby die eiendomme in die Bylae hiervan volledig beskryf, tot Nasionale Gedenkwaardigheede.

#### BYLAE

#### 1. LITTLE CHELSEA, GELEË TE WINDERMERE- WEG 18, DURBAN

##### Beskrywing:

Die eiendom, met inbegrip van die dubbelverdiepinggebou bekend as Little Chelsea daarop, synde Perseel 1 van FF van Z van Perseel 12, Blok G van die Town Lands van Durban 1737, geleë in die stad en county Durban, provinsie Natal, en groot tweehonderd-en-vyftien (215) vierkante meter.

#### 2. DIE FRESHFORDHUISMUSEUM, KELLNER- STRAAT 31, BLOEMFONTEIN

##### Beskrywing:

Die eiendom, tesame met die Freshfordhuismuseum daarop, synde Erf 585 (voorheen Erf 3), geleë in die stad Bloemfontein, distrik Bloemfontein, provinsie die Oranje-Vrystaat, en groot eenhonderd een-en-twintig (121) vierkante roede.

Kroongrondbrief 71/1949, gedateer 3 Augustus 1949 (par 9).

#### 3. DIE NEDERDUITSE GEREFORMEERDE MOE- DERKERKGEBOU EN SAREL CILLIERS- STANDBEELD, KROONSTAD

##### Beskrywing:

Die eiendom, tesame met die Nederduitse Gereformeerde Moederkerkgebou en Sarel Cilliers-standbeeld daarop, synde 'n sekere stuk grond bekend as Kerkplein (nou Erf 426), geleë in die dorp Kroonstad, distrik Kroonstad, en groot 25 431,6 vierkante meter.

Transportakte 30119/1884, gedateer 17 Julie 1884.

#### 4. DIE OU LANDDROSKANTOORGEBOU, LIE- BENBERGTREKSTRAAT, PARYS

##### Beskrywing:

Die Ou Landdroskantoorgebou, geleë op Erwe 17 en 18 in die dorp Parys, distrik Vredefort (tans deel van die distrik Parys), provinsie die Oranje-Vrystaat.

Kroongrondbrief 6/1948, gedateer 27 Januarie 1948.

#### 5. DIE KLIPHUTNEDERSETTING, TAFELKOP, DISTRIK ERMELO

##### Beskrywing:

Die eiendom met die Kliphutnedersetting daarop word soos volg beskryf: Die figuur ABCDEA stel voor 'n proklamasiegebied oor Gedeelte 4 van die plaas Tafelkop 270, Registrasie-afdeling IS, provinsie Transvaal, soos aangedui op Landmeterskaart LG A583/85, geda 4 Maart 1985, en geliasseer in die Kantoor van die landmeter-generaal in Pretoria.

### DECLARATION OF PROPERTIES AS NATIONAL MONUMENTS

By virtue of the powers vested in me by section 10 (1) of the War Graves and National Monuments Act 1969 (Act 28 of 1969), I, Frederik Willem de Klerk, Minister of National Education, hereby declare the properties as fully described in the Annexure hereto, to be national monuments.

#### ANNEXURE

#### 1. LITTLE CHELSEA, SITUATED AT 18 WINDER- MERE ROAD, DURBAN

##### Description:

The property, inclusive of the double-storeyed building known as Little Chelsea thereon, being Lot 1 of FF of Z of Lot 12, Block G of the Town Lands of Durban 1737, situate in the City and County of Durban, Province of Natal, in extent two hundred and fifteen (215) square metres.

Deed of Transfer 19695/1973, dated 23 November 1973.

#### 2. THE FRESHFORD HOUSE MUSEUM, 31 KELLNER STREET, BLOEMFONTEIN

##### Description:

The property, together with the Freshford House Museum thereon, being Erf 585 (formerly Erf 3), situated in the City of Bloemfontein, District of Bloemfontein, Province of the Orange Free State, in extent one hundred and twenty-one (121) square roods.

Crown Grant 71/1949, dated 3 August 1949 (par. 9).

#### 3. THE NEDERDUITSE GEREFORMEERDE MOTHER CHURCH BUILDING AND SAREL CILLIERS STATUE, KROONSTAD

##### Description:

The property, together with the Nederduitse Gereformeerde Mother Church building and Sarel Cilliers statue thereon, being a certain piece of land known as Church Square (now Erf 426), situated in the Township of Kroonstad, District of Kroonstad, in extent 25 431,6 square metres.

Deed of Transfer 30119/1884, dated 17 July 1884.

#### 4. THE OLD MAGISTRATE'S OFFICE BUILDING, LIEBENBERGTREK STREET, PARYS

##### Description:

The Old Magistrate's Office building, situated on Erven 17 and 18 in the Township of Parys, District of Vredefort (now part of the District of Parys), Province of the Orange Free State.

Crown Grant 6/1948, dated 27 January 1948.

#### 5. THE STONE HUT VILLAGE, TAFELKOP, DIS- TRICT OF ERMELO

##### Description:

The property with the Stone Hut Village thereon is described as follows: The figure ABCDEA represents a proclaimed site over Portion 4 of the farm Tafelkop 270, Registration Division IS, Province of the Transvaal, as indicated on Surveyor's Diagram LG A583/85, dated 4 March 1985, and filed in the Office of the Surveyor-General in Pretoria.

Deed of Transfer 6567/1935, dated 15 May 1935 (par. 1).
