

6. THE DOUBLE-STOREYED TOWNHOUSE, SITUATED AT 132A MAIN STREET, PAARL

*Description:*

The property, together with the double-storeyed Georgian townhouse thereon, described as certain piece of land, being the remainder of Erf 3587, Paarl, situate in the Municipality of Paarl, Division of Paarl, in extent one thousand three hundred and five (1 305) square metres.

7. THE DEEDS OFFICE BUILDING, SITUATED ON THE CORNER OF ALEXANDRA ROAD AND QUEEN ROAD, KING WILLIAM'S TOWN

8. THE MAIN POST OFFICE BUILDING, SITUATED IN LONGMARKET STREET, PIETER-MARITZBURG

*Description:*

The Main Post Office Building, situate on a portion of the Remainder of Erf 22 (known as the Remainder of Erf 2622), and Erf 23 (now known as Erf 2623), situate in the City of Pietermaritzburg, Province of Natal.

Deed of Transfer 839/1899, dated 1 July 1899 (pars. 1 and 2).

9. THE HISTORIC HOMESTEAD OF THE FARM DEVONSHIRE, AT SALEM, DISTRICT OF ALBANY

*Description:*

The historic Devonshire farmhouse, together with 10 metres of surrounding land, situate on portions of the following properties:

(a) Certain piece of land, situate in the Division of Albany, being a portion of the Location of Hezekiah Sephton or Salem Party Allotment 23 (now known as Farm 521); and

(b) certain piece of land, situate as above, being a portion of the Location of Hezekiah Sephton or Salem Party Allotment 50 (now known as Farm 547).

10. THE DUTCH REFORMED CHURCH COMPLEX, SITUATED AT 13 BATH STREET, MONTAGU

*Description:*

The property, together with the Dutch Reformed Church building, the outbuildings and the Church clock thereon, as well as the trelliswork fence around the property, being certain lot of land marked No. 81 for Church (now known as the Remainder of Erf 333, Montagu), situate in the Village of Montagu, Division of Swellendam, in extent three thousand six hundred and fifty-eight (3 658) square metres.
