

(ix) **Nos. 87, 89 and 91 Cradock Street, Graaff-Reinet**

Description:

The Victorianised Cape Dutch dwelling-house, together with the garage and Karoo style annex, situated on the following erven:

Erf 628, Graaff-Reinet, situate in the Municipality and Division of Graaff-Reinet, in extent 122 (one hundred and twenty-two) square metres; and

the Remainder of Erf 622, Graaff-Reinet, situate as above, in extent 1 876 (one thousand eight hundred and seventy-six) square metres.

(xii) **No. 18 Church Street, Graaff-Reinet**

Description:

The old library building known as the Reinet Museum, situated on the following erven:

The facade of the Victorian dwelling-house situated on certain piece freehold land, being the Remainder of Erf 1161, Graaff-Reinet, in the Municipality and Division of Graaff-Reinet, in extent 290 (two hundred and ninety) square metres.
