

(xxvii) No. 2 Parsonage Street, Graaff-Reinet

Description:

The Georgian dwelling-house situated on certain piece of land, being Erf 1545, Graaff-Reinet, in the Municipality and Division of Graaff-Reinet, in extent 524 (five hundred and twenty-four) square metres.
