DECLARATION OF PROPERTIES AS NATIONAL MONUMENTS

By virtue of the powers vested in me by section 10(1) of the National Monuments Act, 1969 (Act 28 of 1969), I Frederik Willem de Klerk, Minister of National Education, hereby declare the properties as fully described in the Annexure hereto, to be national monuments.

1. THE OLD HOSTEL BUILDING, TWEESPRUIT AGRICULTURAL HIGH SCHOOL, DISTRICT OF EXCELSIOR

Description:

The old hostel building (formerly the stables of the former Tweespruit Experimental Farm) situated on a portion of the site of the Tweespruit Agricultural High School, on a certain farm named Tweespruit 80, District of Bloemfontein (now part of the District of Excelsior).

Deed of Transfer 653/1902, dated 18 July 1902.

2. THE KAROO-STYLE DWELLING-HOUSE SITU-ATED AT 13 RYNEVELD SQUARE, GRAAFF-REI-NET

Description:

The Karoo-style dwelling-house situate on Erf 198, Graaff-Reinet. in the Municipality and Division of Graaff-Reinet.

3. THE OLD DRILL HALL, SITUATED IN DARLING STREET, CAPE TOWN

The external facades, including the exterior of the roof of the Old Drill Hall Building, situate on Erf 9808 (a portion of Erf 4944), Cape Town, in the Municipality of Cape Town and described as the figure A. B. C. D. E. F. G. H. J. K. L. M. on Survey Diagram LG 4492/78, dated 4 August 1978, filed in the office of the Surveyor-General in Cape Town and on file 3/K/Kaa/66 in the office of the National Monuments Council in Cape Town.
