1. THE SO-CALLED C. E. FRÖELICH SHOP BUILDING SITUATED AT 58 VOORTREKKER STREET, PEARSTON

## Description:

The so-called C. E. Fröelich Shop Building, situated on Erf 288, Pearston, in the Municipality and Division of Pearston.

2. DIE SOGENAAMDE HUNTINGTON-HUIS EN DIE PERDESTALLE, TE SABIE, DISTRIK PELGRIMSRUS

*Beskrywing:*
