Die hoofgebou en skoolsaal, geleë op 'n gedeelte van sekere stuk grond (nou bekend as Erf 536), in die dorp Ladybrand, distrik Ladybrand.

6. DIE EIENDOM MET DIE OU WESBANK-POSKANTOORGEBOUITJIE DAAROP, TE OOSLONDEN

*Beskrywing:*

7. DIE NEDERDUITSE GEREFORMEERDE KERKGEBOU, GELEË IN LOOPSTRAAT, RICHMOND, KAAPPROVINSIE

*Beskrywing:*

Die Nederduitse Gereformeerde Kerkgebou, geleë op 'n sekere stuk erfpaggrond (omgeskep tot eiendomsgrond), genaamd N.G. Kerkperseel, gedeelte van Driefontein, (nou bekend as Erf 326, Richmond), geleë in die munisipaliteit en afdeling Richmond, Kaapprovinsie.

Sertifikaat van registreerde Titel 9664/1938, gedateer 16 September 1938 (par. 2).

*Description:*

The facade of the Town Hall building, situate on a portion of Erf 474, Cathcart, in the Municipality and Division of Cathcart.

The facade of the Public Library building, situated in Main Street, Cathcart.

*Description:*

The facade of the Public Library building, situated on a portion of certain piece of land, being the remainder of Erf 268, Cathcart, situate in the Municipality and Division of Cathcart.

The facades of the so-called Elliotts Building and the Cathcart Fruiterers Building, situated in Main Street, Cathcart.

The main building and school hall, situated on a portion of certain piece of land (now known as Erf 536) in the Town of Ladybrand, District of Ladybrand.

6. THE PROPERTY WITH THE OLD WEST BANK POST OFFICE BUILDING THEREON, AT EAST LONDON

*Description:*

The property inclusive of the old West Bank Post Office building thereon, being a certain piece of perpetual quitrent land, situate in the Old Town and Village of East London, Division of East London, being Lot 105 (now known as Erf 19932, East London), in extent 607 (six hundred and seven) square metres.

7. THE DUTCH REFORMED CHURCH BUILDING, SITUATED IN LOOP STREET, RICHMOND, CAPE PROVINCE

The Dutch Reformed Church building, situate on a certain piece of quitrent land (converted into freehold land), named D.R. Church Site, portion of Driefontein (now known as Erf 326, Richmond), situate in the Municipality and Division of Richmond, Cape Province.
