

8. DIE EERSTE NEDERDUITSE GEREFORMEERDE KERKGEBOU, GELEE OP DIE STADSPLEIN, TE PIETERSBURG

*Beskrywing:*

Die Eerste Nederduitse Gereformeerde Kerkgebou, geleë op 'n gedeelte van Gekonsolideerde Erf 6045 (voorheen bekend as Erf 52), in die dorp Pietersburg, registrasie-afdeling LS, Transvaal.

9. DIE EIENDOMME, TESAME MET DIE WOONHUIS (VOORHEEN DIE NEDERDUITSE GEREFORMEERDE PASTORIE) EN BUITEGEBOU DAAROP, GELEE TE DU PLESSISSTRAAT 33, PETRUS STEYN, DISTRIK LINDLEY

*Beskrywing:*

Die eiendomme, tesame met die woonhuis (voorheen die Nederduitse Gereformeerde Pastorie) en buitegebou daarop, bestaande uit die volgende erwe:

11. DIE SOGENAAMDE "REMEDIAL MODEL PRIMARY SCHOOL"-GEBOU, GELEE TE LOOPSTRAAT 310, PIETERMARITZBURG

*Beskrywing:*

8. THE FIRST DUTCH REFORMED CHURCH BUILDING, SITUATED ON THE TOWN SQUARE, AT PIETERSBURG

*Description:*

The First Dutch Reformed Church building, situate on a portion of Consolidated Erf 6045 (formerly known as Erf 52), in the Town of Pietersburg, Registration Division LS, Transvaal.

9. THE PROPERTIES, TOGETHER WITH THE DWELLING-HOUSE (FORMERLY THE NEDERDUITSE GEREFORMEERDE PARSONAGE) AND OUTBUILDING THEREON, SITUATED AT 33 DU PLESSIS STREET, PETRUS STEYN, DISTRICT OF LINDLEY

*Description:*

The properties, together with the dwelling-house (formerly the Nederduitse Gereformeerde Parsonage) and outbuilding thereon, consisting of the following erven:

- (a) Erf 413, situated in the Town of Petrus Steyn, District of Lindley, in extent 2 974 (two thousand nine hundred and seventy-four) square metres; and

11. THE SO-CALLED REMEDIAL MODEL PRIMARY SCHOOL BUILDING, SITUATED AT 310 LOOP STREET, PIETERMARITZBURG

*Description:*

The so-called Remedial Model Primary School building, inclusive of the piece of land in front of the building up to and bordered by Loop Street, as well as a 10 metre wide stretch of land at the rear of the building, situated on portions of the undermentioned erven:
