

2. DIE EIENDOM, MET INBEGRIJP VAN DIE VICTORIAANSE WOONHUIS BEKEND AS BONA VESTA DAAROP, GELEË TE PASTORIESTRAAT 7, PRINS ALBERT

*Beskrywing*

Die eiendom tesame met die Victoriaanse woonhuis bekend as Bona Vesta daarop, beskryf as sekere stuk grond, synde die restant van Erf 570, Prins Albert, geleë in die munisipaliteit en afdeling Prins Albert en groot eenduisend seshonderd en sewe (1 607) vierkante meter.

5. DIE EIENDOM MET DIE SOGENAAMDE MILL COTTAGE DAAROP, GELEË TE VOORTREKKERSTRAAT 243, SWELLENDAM

*Beskrywing*

Die eiendom tesame met die sogenaamde Mill Cottage daarop, synde die restant van Erf 651, Swellendam geleë in die munisipaliteit en afdeling Swellendam, en groot 2 944 (tweeduisend negehonderd vier-en-veertig) vierkante meter.

6. DIE GEORGIAANSE DUBBELVERDIEPING- WOONHUIS, GELEË TE WESTSTRAAT 19, GRAHAMSTAD

*Beskrywing*

6. THE GEORGIAN DOUBLE-STORYED DWELLING-HOUSE SITUATED AT 19 WEST STREET, GRAHAMSTOWN

*Description*

- (i) Erf 4459, Grahamstown, situate in the Municipality of the City of Grahamstown, Division of Albany, in extent 347 (three hundred and forty-seven) square metres; and
