

7. THE STATION BUILDING SITUATED ON THE SITE OF THE RAILWAY STATION AT HEILBRON

*Description*

The station building, together with 10 metres of surrounding land, situated on a portion of the remainder of certain Erf 436, in the Township of Heilbron, District of Heilbron.

8. THE SO-CALLED NOOITGEDACHT DWELLING-HOUSE SITUATED AT 1 CHURCH SQUARE AND THE SEMI-DETACHED HOUSES SITUATED AT 157-161 MAIN STREET, PAARL

*Description*

The property inclusive of the so-called Nooitgedacht dwelling-house, as well as the semi-detached houses thereon, being Erf 14490, a portion of Erf 8723, Paarl, situate in the Municipality and Administrative District of Paarl, in extent three thousand seven hundred and forty-five (3 745) square metres.

10. THE PROPERTY WITH THE VICTORIAN DWELLING-HOUSE THEREON, SITUATED AT 394-396A MAIN STREET, PAARL

*Description*

The property, inclusive of the Victorian dwelling-house thereon, being Erf 4702, Paarl, situate in the Municipality and Division of Paarl, in extent one thousand four hundred and twenty-six (1 426) square metres.

11. THE DWELLING-HOUSE SITUATED ON THE FARM FERREIRASRUST 163, DISTRICT OF HEN-NENMAN

*Description*

12. THE FACADE OF THE SO-CALLED BEAUMONT AND RICE BUILDING, SITUATED AT 112 HIGH STREET, GRAHAMSTOWN

The facade of the so-called Beaumont and Rice building, situate on a portion of certain piece of land in the Municipality of the City of Grahamstown, Division of Albany, being Lot JCP (now known as Erf 3686, Grahamstown).
