

4. DIE EIENDOM MET DIE RIETDAKHUIS BEKEND AS KAAPSEDRAAI DAAROP, GELEË TE HOOGSTRAAT 165 EN 165A, WORCESTER

*Beskrywing*

7. DIE GEREFORMEERDE KRUISEKERK, GELEË IN LIEBENBERGSTRAAT, STRYDENBURG, DISTRIK HOPETOWN

*Beskrywing*

8. DIE VICTORIAANSE WOONHUIS, GELEË TE PRESIDENTSTRAAT 95, VRYHEID

*Beskrywing*

4. THE PROPERTY WITH THE THATCHED-ROOFED DWELLING KNOWN AS KAAPSE-DRAAI THEREON, SITUATED AT 165 AND 165A HIGH STREET, WORCESTER
