

7. THE SETTLER COTTAGE SITUATED AT 87 LORNE STREET, ESTCOURT, NATAL

Description

The property inclusive of the early Settler cottage thereon, being Lot 126, Estcourt Township, situated in the borough of Estcourt, County of Weenen, Province of Natal, in extent 4 046 (four thousand and forty six) square metres.
