1. THE UNION MASONIC TEMPLE, SITUATED AT 4 FREESTATE ROAD, KIMBERLEY.

*Description*

The property together with the so-called Union Masonic Temple thereon, being certain Erf 1895, Kimberley, situated in the Municipality of the City of Kimberley, Division of Kimberley, in extent 426 (four hundred and twenty-six) square metres.
