**DECLARATION OF A MOVABLE CULTURAL TREASURE.—THE SO-CALLED JAN SMUTS STUDY, AS HOUSED IN THE JAN SMUTS HOUSE AT THE UNIVERSITY OF THE WITWATERSRAND, JOHANNESBURG**

In terms of section 5 (1) (cD) of the National Monuments Act, 1969 (Act No. 28 of 1969), the National Monuments Council hereby declares the so-called Jan Smuts Study, as housed in the Jan Smuts House at the University of the Witwatersrand, Johannesburg, as fully described in the Schedule hereto, to be a cultural treasure because of its historical and cultural importance.

The so-called Jan Smuts Study, consisting of the contents of General Smuts's Study at Doringkloof, including the books, articles of furniture, cartoons, photographs, miscellaneous pamphlets, cuttings and various other objects that are housed in the Jan Smuts House at the University of the Witwatersrand, Johannesburg, in the care of the Smuts Memorial Trust in terms of the Deed of Trust D.70/58.
