

2. THE HISTORIC CAPE DUTCH HOME-STEAD ON THE FARM NEDERBURG, IN THE DISTRICT OF PAARL

Description:

The historic Cape Dutch homestead, situated on a portion of certain piece of partly freehold and partly abolished quitrent land, at Klein Drakenstein, in the Division of Paarl and partly in the Municipality of Paarl, being the Remainder of the farm Nederburg Estates, in the Palmiet River Irrigation Area.

4. THE BATTLE OF CONGELLA SITE, SITUATED AT MAYDON WHARF, DURBAN
