1. **United Municipalities of South Africa (H4/3/1/3239)**

Wapen: In silwer, 'n swart mier met rooi voelers; 'n blou skildhoof gewelfd van twee stukke.

Helmteken: Op die kantele van 'n uitkomende swart toring, silwer gemessel, 'n fontein.

Wring en dekklede: Silwer en blou

2. **Tegniese Kollege Northdale (H4/3/1/3313)**

Wapen: Deursnede, silwer en blou, in die skildhoof ses oranje punte na 'n punt en in die skildvoet 'n silwer halwe tandrat uitkomend uit die verdeelingslyn; op die middelpunt 'n skyf deursnede van oranje en silwer binne-in 'n ring, ook deursnede, silwer en blou, die silwer belaaï met vyf blou vyfpuntige sterre.

SECTION 7A EN B OF THE HERALDRY ACT, 1962 (ACT No. 18 OF 1962)

The undermentioned bodies and persons have applied in terms of section 7 of the Heraldry Act, 1962 (Act No. 18 of 1962), for the registration of their heraldic representations and name. Anyone wishing to object to the registration of these heraldic representations or name on the grounds that such registration will encroach upon rights to which he is legally entitled should do so within one month of the date of publication of this notice upon a form obtainable from the State Herald, Private Bag X236, Pretoria, 0001.

1. **United Municipalities of South Africa (H4/3/1/3239)**

Arms: Argent, an ant Sable, tentacles Gules; a chief double enarched Azure.

Crest: On the battlements of a tower issuant Sable, masoned Argent, a fountain.

Wreath and mantling: Argent and Azure

2. **Northdale Technical College (H4/3/1/3313)**

Arms: Per fess Argent and Azure, in chief six piles in point Orange and in base a demi-cogwheel issuant from the partition Argent; at fess point a roundel per fess Orange and Argent, with-in an annulet also per fess, Argent and Azure, the former charged with five mullets of the latter.

Motto: CRESCERE IN LUCE SCIENTIAE
