LEVYING OF DIPPING RATE.

The State President has been pleased in terms of the powers vested in him by sub-section (2) of section five of the Bantu Authorities Act, 1951 (Act No. 68 of 1951), as amended, to approve the enactments in the accompanying Schedule which have been made by the Hewu Regional Authority, as made known by Government Notice No. 564 of 14th April, 1961, in terms of the said sub-section (2) of section five of the Bantu Authorities Act, 1951.

SCHEDULE.

ENACTMENTS OF THE HEWU REGIONAL
AUTHORITY.—DIPPING RATE.

1. Every Bantu resident in the area of the Hewu Regional Authority who owns cattle, horses, sheep or goats or who has cattle, horses, sheep or goats under his supervision in such area shall pay for the dipping services rendered by the said Regional Authority a rate of five cents in respect of every head of cattle, ten cents in respect of every horse and one cent in respect of every sheep or goat, over the age of six months in his possession or under his supervision on the date on which such rate is due.

2. The rate imposed in terms of section 1 of these enactments is due on the date of publication hereof in respect of the year 1965, and thereafter on the first day of January of every succeeding year and shall be paid at the office of the Treasurer of the Hewu Regional Authority.

3. A person who is not subject to the provisions of section 1 of these enactments and who wishes to dip cattle, horses, sheep or goats in the dipping tanks under the control of the Hewu Regional Authority, shall pay in advance the sum of five cents for each head of cattle, ten cents for each horse and one cent for each sheep or goat which he desires to be dipped.

Before such person may make use of such dipping tank to dip cattle, horses, sheep or goats, he shall furnish proof that he has paid such rate to the person who has been designated by the Regional Authority to take charge of the tank concerned.

MAATREËLS VAN DIE HEWUSTREEKS-
OWERHEID.—DIPBELASTING.

1. Elke Bantoe wat in die gebied van die Hewustreeks-owerheid woonagtig is en in sodanige gebied beeste, perde, skape of bokke besit of onder sy toesig het, moet vir die dipdienste wat deur daardie streeksowerheid beskikbaar gestel word, 'n belasting van vyf sent betaal vir elke bees, tien sent vir elke perd en een sent vir elke skaap of bok bo die ouderdom van ses maande wat op die datum waarop sodanige belasting verskuldig is, in sy besit of onder sy toesig is.

2. Die belasting gehef kragtens artikel 1 van hierdie maatreëls is verskuldig op die datum van afkondiging hiervan ten opsigte van die jaar 1965 en daarna op die eerste dag van Januarie van elke daaropvolgende jaar en moet by die kantoor van die Hewustreeksowerheid se Tesourier betaal word.

3. 'n Persoon wat nie aan die bepalings van artikel 1 van hierdie maatreëls onderworpe is nie en wat beeste, perde, skape of bokke in 'n dipbak onder die beheer van die Hewustreeksowerheid wil dip, moet vooruit 'n bedrag van vyf sent betaal vir elke bees, tien sent vir elke perd en een sent vir elke skaap of bok wat hy wil dip.

Alvorens sodanige persoon sodanige dipbak mag gebruik om beeste, perde, skape of bokke te dip, moet hy aan die persoon wat deur die Streeksowerheid aangewys is om beheer oor die dipbak uit te oefen, bewys lewer dat hy sodanige bedrag betaal het.
