

2. THE BUILDING KNOWN AS THE GRAAFF-REINET CLUB, INCLUDING THE FRONT BOUNDARY WALL, AS WELL AS THE PORTION OF LAND SITUATED BETWEEN THE BUILDING AND CHURCH STREET, AT 3 CHURCH STREET, GRAAFF-REINET

*Description*

The building known as the Graaff-Reinet Club, including the front boundary wall, as well as the portion of land situated between the building and Church Street, situated on certain piece of land, being Portion A of a subdivision of Erf 2 (now known as Erf 1483, Graaff-Reinet), in the Municipality and Division of Graaff-Reinet.

Deed of Transfer T10334/1926, dated 18 October 1926 (para. 1).

3. THE HISTORIC 1907-1908 PORTION OF THE KAREL THERON PRIMARY SCHOOL BUILDING IN VICTORIA STREET, MIDDELBURG, CAPE PROVINCE

*Description*

The historic 1907-1908 portion of the Karel Theron Primary School building, situated on a portion of certain portion and land, being Erf 1, Middelburg (now known as Erf 920, Middelburg), in the Town and Municipality of Middelburg, Cape Province.

Deed of Transfer T11305/1905, dated 27 November 1905.

4. THE BUILDING KNOWN AS *KROMM'S INN*, AT 3 PARLIAMENT STREET, GRAAFF-REINET

*Description*

The building known as *Kromm's Inn*, situated on a portion of Erf 1178, Graaff-Reinet, in the Municipality and Division of Graaff-Reinet.

Deed of Transfer T25619/1987, dated 17 June 1987.

5. THE PROPERTY, WITH THE HOUSE KNOWN AS *PELYN THEREON*, IN ASCOT ROAD, KENILWORTH, CAPE TOWN

*Description*

The property, with the house known as *Pelyn thereon*, described as follows:

- (i) Certain piece of land at Kenilworth (now known as Erf 65154, Cape Town at Kenilworth), situated in the City of Cape Town, Cape Division, in extent 1 025 (one thousand and twenty-five) square metres.
- (ii) Certain piece of land at Kenilworth (now known as the remainder of Erf 65153, Cape Town at Kenilworth), situated in the City of Cape Town, Cape Division, in extent 986 (nine hundred and eighty-six) square metres.
- (iii) Certain piece of land, being Portion 1 of Erf 5, Kolara Subdivided Estate (now known as Erf 65144, Cape Town at Kenilworth), situated in the City of Cape Town, Cape Division, in extent 793 (seven hundred and ninety-three) square metres.
