

5. THE DUTCH REFORMED CHURCH BUILDING  
IN MOLTENO STREET, BARKLY EAST

*Description*

The Dutch Reformed Church building, situated on a portion of certain piece of land marked No. 76 (now known as Erf 1191, Barkly East), situated in the Village of Barkly East, Division of Barkly East.

6. THE HISTORIC MORAVIAN MISSION CHURCH  
AND PARSONAGE, SITUATED ON THE FARM  
GOEDVERWACHT 146, IN THE DIVISION OF  
PIKETBERG

*Description*

The historic Moravian Mission Church and Parsonage, situated on portions of certain piece of abolished quitrent land, partly in and partly out of the local area of Goedeverwagting and Wittewater, being the farm Goedverwacht 146, in the Division of Piketberg.

AND THE PROPERTY WITH THE *BLETTER-  
MAN ANNEXE*, the *OLD COLLEGE BUILDING*  
(GYMNASIUM) AND THE SO-CALLED *ARTS  
DEPARTMENT BUILDING* THEREON. RES-  
PECTIVELY SITUATED ON THE CORNER OF  
PLEIN AND RYNEVELD STREETS, AND IN  
RYNEVELD STREET, STELLENBOSCH
