WYKSVLEI-DAM, VANWYKSVLEI, DISTRIK  
CARNARVON

*Beskrywing*

Die damwal en toring van die Vanwyksvlei-dam, geleë op sekere gedeelte grond bekend as die "Van Wyks Vlei Settlement Village Commonage", gedeelte van "The Van Wyks Vlei Settlement" (nou bekend as die Restant van Erf 35, Van Wyks Vlei-nedersetting), geleë in die afdeling Carnarvon.

Sertifikaat van Geregistreeerde Titel 1827/1934, gedateer 16 Maart 1934 (Endossement, bladsy 4).

2. DIE EIENDOM MET DIE HUIS BEKEND AS  
WOBURN LODGE EN DIE SKUUR DAAROP,  
TE WATERKANTSTRAAT 12, PIKETBERG

*Beskrywing*

Die eiendom met die historiese huis bekend as Woburn Lodge en die skuur daarop en soos volg beskryf:

1. Erf 84, Piketberg, geleë in die munisipaliteit en afdeling Piketberg, en groot 171 (eenhonderd een-en-sewentig) vierkante meter; en
2. Erf 85, Piketberg, geleë in die munisipaliteit en afdeling Piketberg, en groot 2 675 (twee-duisend seshonderd vyf-en-sewentig) vierkante meter.

NATIONAL MONUMENTS ACT

DECLARATION OF PROPERTIES TO BE  
NATIONAL MONUMENTS

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act No. 28 of 1969), I, Pieter Gabriel Marais, Minister of National Education, hereby declare the properties as fully described in the Schedule hereto to be national monuments.

**SCHEDULE**

1. THE DAM WALL AND TOWER OF THE VAN-  
WYKSVLEI DAM, VANWYKSVLEI, IN THE DIS-  
TRICT OF CARNARVON

*Description*

The dam wall and tower of the Vanwyksvlei Dam, situated on certain piece of land known as the Van Wyks Vlei Settlement Village Commonage, portion of "The Van Wyks Vlei Settlement" (now known as the Remainder of Erf 35, Van Wyks Vlei Settlement), situated in the Division of Carnarvon.

Certificate of Registered Title 1827/1934, dated 16 March 1934 (Endorsement, page 4).

2. THE PROPERTY WITH THE HOUSE KNOWN  
AS WOBURN LODGE AND THE BARN THEREON,  
AT 12 WATERKANT STREET, PIKETBERG

*Description*

The property with the historical house known as Woburn Lodge and the barn thereon, described as follows:

1. Erf 84, Piketberg, situated in the Municipality and Division of Piketberg, in extent 171 (one hundred and seventy-one) square metres; and
2. Erf 85, Piketberg, situated in the Municipality and Division of Piketberg, in extent 2 675 (two thousand six hundred and seventy-five) square metres.

3. THE PROPERTY, BEING THE REMAINDER OF  
ERF 947, WITH THE SO-CALLED OUMA

The property with the so-called Ouma Granny's House thereon, being the Remainder of Erf 947, Wellington, situated in the Municipality of Wellington, Division of Paarl, in extent 820 (eight hundred-and-twenty) square metres.
