DECLARATION OF PROPERTIES TO BE
NATIONAL MONUMENTS

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act No. 28 of 1969), I, Pieter Gabriel Marais, Minister of National Education, hereby declare the properties as described in the schedule hereto to be national monuments.

SCHEDULE

1. THE FARM SPRINGFIELD 287, DISTRICT OF BREDASDORP

Description

The property, being certain piece of abolished quitrent land, known as Springfield 287, situated in the Division of Bredasdorp, in extent 1742, 7627 (one seven four two comma seven six two seven) hectares.

Deed of Transfer T24051/1948, dated 21 October 1948.

2. THE ST. JOSEPH'S HOME FOR CHILDREN TOGETHER WITH THE PROPERTY ON WHICH IT IS SITUATED, BEING PORTIONS 53 AND 54 OF THE FARM WATERVAL 211, DISTRICT OF JOHANNESBURG

Description

The St. Joseph's Home for Children together with the property on which it is situated, being Portions 53 and 54 of the farm Waterval 211 in the District of Johannesburg, in extent 2,9179 (two comma nine one seven nine) and 5,4104 (five comma four one nought four) hectares respectively.

Deeds of Transfer T2425/1923 and T2426/1923, dated 20 March 1923.

3. THE BUILDING AT PRESENT KNOWN AS THE CAPE EDUCATION MUSEUM, IN ALI WAL STREET, WYNBERG, CAPE TOWN

Description

The building previously known as the Aliwal Road Primary School, now known as the Cape Education Museum, situated on a portion of certain remaining extent of a piece of ground (now known as Remainder of Erf 66445), in the Cape Division, at Wynberg.
