

## DESCRIPTION.

*Original Building at Pinehurst, Oudtshoorn.*

Certain piece of land with the original building thereon known as Pinehurst, excluding the later additions completed in 1964, situate in the Municipality and Division of Oudtshoorn, being Lots Nos. 361 to 365 (now Erf No. 734, Oudtshoorn), measuring 11 morgen 162 square rods (Diagram No. 1732/1894, filed with Registration Duplicate of Deed of Transfer No. 6551/1894, dated 17th November, 1894).

## HISTORICAL INTEREST.

The original building Pinehurst is one of the so-called ostrich palaces built at the beginning of the present century when the ostrich feather industry reached its peak.

## PROCLAMATION OF A MONUMENT.

By virtue of the powers vested in me by section 8 (1) (a) of the Natural and Historical Monuments, Relics and Antiques Act, 1934 (Act No. 4 of 1934), as amended, I hereby proclaim a certain piece of land with the original buildings thereon known as "Auld House", situate in the Municipality and Division of Swellendam, to be a monument.

## DESCRIPTION.

*The "Auld House", Swellendam.*

Certain land registered under Deed of Transfer No. 4359, dated 19th May, 1924, with the buildings thereon, including the boundary walls of the property, comprising—

- (a) certain land, in the Municipality and Division of Swellendam. Diagram No. 14/1802 (now known as Erf No. 1115, Swellendam), measuring 160 square rods; and
- (b) portion of certain land in the Municipality and Division of Swellendam. Diagram No. 348/1816 (now known as Erf No. 1116, Swellendam), measuring 1 morgen 337 square rods 88 square feet, bounded as follows:—

On the north by Voortrek Street, on the east by Van Riebeeck Park, on the south by the middle of Koorndlands River, on the west by Erf No. 1113 and Crown Land and by Erf No. 1101 and Crown Land.

## HISTORICAL INTEREST.

The "Auld House" is a particularly fine old Cape house with interesting associations with the historic Barry family.

- (b) gedeelte van sekere grond in die Munisipaliteit en Afdeling Swellendam. Kaart No. 348/1816 (nou bekend as Erf No. 1116, Swellendam), groot 1 morg 337 vierkante roede 88 vierkante voet, begrens soos volg:—

Aan die noordekant deur Voortrekstraat, aan die oostekant deur Van Riebeeckpark, aan die suidekant deur die middel van die Koorndlandsrivier, aan die westekant deur Erf No. 1113 en kroongrond en Erf No. 1101 en kroongrond.
