PROVISIONAL DECLARATION AS A NATIONAL MONUMENT: THE PROPERTY WITH THE HISTORIC PHOENIX SETTLEMENT AND THE SO-CALLED SARVODAYA DWELLING-HOUSE OF MAHATMA GANDHI THEREON, AT PHOENIX, KWA-ZULU/NATAL

In terms of section 5 (1) (c) of the National Monuments Act, 1969 (Act No. 28 of 1969), the National Monuments Council hereby provisionally declares the property with the historic Phoenix Settlement and the so-called Sarvodaya dwelling-house of Mahatma Gandhi thereon, at Phoenix in KwaZulu/Natal, as fully described below, to be a national monument.

Description

The property with the historic Phoenix Settlement and the so-called Sarvodaya dwelling-house of Mahatma Gandhi thereon, being—

- (i) Portion 1 of Lot D of Lot A of the farm Piezang River, situated in the Province of KwaZulu/Natal, in extent approximately 8,094 (eight comma nought nine four) hectares; and
- (ii) the Remainder of Portion D of Lot A of the farm Piezang River, situated in the Province of KwaZulu/Natal, in extent approximately 32,378 (three two comma three seven eight) hectares.

PROVISIONAL DECLARATION AS A NATIONAL MONUMENT: THE OLD VAN WYK'S RUST GAOL, JOHANNESBURG

In terms of section 5 (1) (c) of the National Monuments Act, 1969 (Act No. 28 of 1969), the National Monuments Council hereby provisionally declares the old Van Wyk's Rust gaol, Johannesburg, as fully described below, to be a national monument.

Description

The old Van Wyk's Rust gaol, situated on Portions 19, 40, 50 and 51 of the farm Olifantsvlei 316, Registration Division IQ, Transvaal, with a surrounding portion of land, described as that portion bordered by a line joined by four points, each point defined by decimal geographical co-ordinates, and stretching from point R1 (26,33853357 S 27,90170968 E); thence for a distance of 107,6 (one nought seven comma six) metres to point R2 (26,33786420 S 27,90092887 E); thence for a distance of 145 (one four five) metres to point R3 (26,33898209 S 27,90017378 E); thence for a distance of 107,6 (one nought seven comma six) metres to point R4 (26,33965147 S 27,90095459 E); and thence for a distance of 145 (one four five) metres up to point R1.

Die ou Van Wyk's Rust tronk, geleë op Gedeelte 19, 40, 50 en 51 van die plaas Olifantsvlei 316, Registrasieafdeling IQ, Transvaal, met 'n omliggende gedeelte grond, beskryf as daardie gedeelte begrens deur 'n lyn verbind deur vier punte, elke punt gedefinieer deur 'n desimale geografiese koördinaat, en strekkende vanaf punt R1 (26,33853357 S 27,90170968 O); vandaar vir 'n afstand van 107,6 (een nul sewe komma ses) meter na punt R2 (26,33786420 S 27,90092887 O); vandaar vir 'n afstand van 145 (een vier vyf) meter na punt R3 (26,33898209 S 27,90017378 O); vandaar vir 'n afstand van 107,6 (een nul sewe komma ses) meter na punt R4 (26,33965147 S 27,90095459 O); en vandaar vir 'n afstand van 145 (een vier vyf) meter tot by punt R1.
