

**2. A PORTION OF THE ATTAQUAS KLOOF PASS IN THE DISTRICTS OF MOSSEL BAY AND OUDTSHOORN**

*Description*

A portion of the pass known as Attaqua Kloof, described as an area which stretches from the centre of the Kamma River at the south-west corner of the Attaqua Kloof Nature Reserve; thence in an easterly direction along the centre of the Kamma River as far as the boundary of the farm Rooi-Hoogs-Kloof 15; thence in an easterly direction as far as Trigonometrical Beacon 86; thence in an easterly direction as far as Beacon 85; thence in a northerly direction along the boundary between the farms Osse Hoek 206 and Eende Kraal 205 as far as the point of convergence of the boundaries of the farms Zeebras Kop 190, Osse Hoek 206 and Eende Kraal 205; thence in a south-westerly direction to the point of convergence of the boundaries of Eende Kraal 205, Fourniesberg 204, Paardekop 13 and Roi-Hoogs-Kloof 15; thence in a westerly direction along the boundary between Fourniesberg 204 and Paardekop 13 up to the point where this boundary is crossed by a straight line between Beacon 89 and the point of beginning; thence in a south-westerly direction along a straight line between Beacon 89 and the point of beginning, the whole area situated on portions of the farms Paardekop 13 and Roi-Hoogs-Kloof 15 in the District of Mossel Bay and the farm Eende Kraal 205 in the District of Oudtshoorn, as marked on a copy of map 3321 DD (1:50 000) on File 9/2/064/6 in the office of the National Monuments Council in Cape Town.
