The house and a portion of the garden, being portion of the farm Glenconnor No. 345, District of Stellenbosch, Province of the Cape of Good Hope, known as Old Nectar, measuring 49,566 square feet as shown in Diagram S.G. 962/64, surveyed in February, 1964 by Surveyor J. M. Landsberg.

HISTORICAL INTEREST.

Old Nectar is architecturally one of the finest and best-known gabled houses of the old Cape type. It is situated on the farm, formerly known as Weltevreden, allotted in 1685.
