DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Pieter Gerhardus Jacobus Koornhof, Minister of National Education, hereby declare Erf 3922 and Erf 3920, with the historic buildings thereon, situated at 5 and 11 Cora Terrace, respectively, Port Elizabeth, to be national monuments.

*Description*

1. Certain piece of land, with the historic building thereon, situate at 5 Cora Terrace, in the Municipality of the City of Port Elizabeth, Division of Port Elizabeth, being Erf 3922, Port Elizabeth Central and measuring two hundred and forty-two (242) square metres.

Deed of Transfer 19389/1975, dated 7.7.1975.

2. Certain land, with the historic building thereon, situate at 11 Cora Terrace, on the Hill in the Municipality of the City of Port Elizabeth, Division of Port Elizabeth, being Lot C, a portion of Erf 13 (now Erf 3920, Port Elizabeth Central) and measuring twelve (12) square rods and four decimal eight (4,8) square feet.
