Beskrywing:
Die eiendom met die plek waar die Merensky-rif ontdek is, daarop, word soos volg beskryf: Die figuur ABCDA stel 4 643 vierkante meter grond voor, synde 'n proklamasieterrein oor die plaas Maandagshoek 254 KT, provinsie Transvaal, soos getoon op Landmeterskaart LG A8278/84, gedateer 24 Oktober 1984, en geliasseer in die Kantoor van die Landmeter-generaal in Pretoria.

Description:
The front facade of the Cape Dutch dwelling-house known as the Old Doctor's House, situate on a certain piece of land in the Municipality and Division of Prince Albert, being the remainder of Erf 463, Prince Albert.

- 11. THE SITE WHERE THE MERENSKY REEF WAS DISCOVERED, SEKHUKHUNELAND**
