VERKLARING VAN DIE EIENDOM MET DIE SOGE-
NAAMDE "BAY VIEW"-HUIS DAAROP, TE
SIMONSTAD

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Gerrit van Niekerk Viljoen, Minister van Nasionale Opvoeding, hierby die eiendom met die sogenaamde "Bay View"-huis daarop, te Simonstad, tot nasionale gedenkwaardigheid.

Beskrywing

Die eiendom met die sogenaamde "Bay View"-huis daarop, synde—

(a) 'n een vyfde deel van 'n sekere stuk grond geleë in die hoofstraat te Simonstad in die munisipaliteit Simonstad, Kaapse Afdeling, synde die resterende gedeelte van Perseel 1 (nou bekend as die resterende gedeelte van Erf 1011, Simonstad), en groot negentien (19) vierkante roede twee-en-vyftig (52) vierkante voet.

(b) 'n vier-vyfde deel van 'n sekere stuk grond geleë in die munisipaliteit Simonstad, Kaapse Afdeling, synde Restant van Erf 1011, Simonstad, en groot tweehonderd ses-en-sewentig (276) vierkante meter.

DECLARATION OF THE PROPERTY WITH THE SO-
CALLED BAY VIEW HOUSE THEREON, AT SIMONS-
TOWN

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Gerrit van Niekerk Viljoen, Minister of National Education, hereby declare the property with the so-called Bay View House thereon, at Simonstown, to be a national monument.

Description

The property with the so-called Bay View House thereon, being—

(a) a one-fifth share in certain piece of land situate on the Main Street in Simonstown in the Municipality of Simonstown, Cape Division, being the remaining extent of Lot 1 (now known as remaining extent of Erf 1011, Simonstown), and measuring nineteen (19) square roods fifty-two (52) square feet

Deed of Transfer 8554/46, dated 7 June 1946; and

(b) a four-fifth share in certain piece of land situate in the Municipality of Simonstown, Cape Division, being Remainder of Erf 1011, Simonstown, and measuring two hundred and seventy-six (276) square metres.

Deed of Transfer 39221/80, dated 17 October 1980.

Historical and architectural interest

This double-storeyed building with its Georgian and Victorian features dates from the year 1803. 10/2/908.
