Beskrywing

Die historiese ou Kaaps-Hollandse herehuis bekend as Bien Donn , met 'n stuk grond daaromheen wat aan die noorde- en oostekant deur die ringmuur begrens word, terwyl die suidelike grens gevorm word deur 'n reguit lyn vanaf die suidelike punt van die oostelike ringmuur in die rigting van die noordelike pilaar van die ingangshek, daarvandaan in 'n westelike rigting in 'n reguit lyn vanaf die noordelike tuinmuur met die rand van die grasperk langs sodat laasgenoemde ingesluit word, tot waar dit die suidelike grenslyn kruis, synde in sy geheel gele  op sekere stuk grond bekend as Bien Donn , in die afdeling Paarl, en groot as sodanig 280,934 4 morg.

Die hoeksteen van hierdie kerk is op 23 Oktober 1891 deur die destydse Kommandant-generaal van Transvaal, genl. P. J. Joubert, gele . Die inwyding van die gebou het daarna op 21 April 1893 plaasgevind.

DECLARATION OF A NATIONAL MONUMENT

Under section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the property known as Bien Donn  at Groot Drakenstein, near Franschhoek, to be a national monument.

Description

The historic old Cape-Dutch homestead, known as Bien Donn , surrounded by a piece of land bounded on the northern and eastern sides by the ringwall and with the southern boundary being formed by a straight line from the southern end of the eastern ring-wall in the direction of the northern pillar of the entrance gate, thence in a westerly direction in a straight line from the northern garden wall along the border of the lawn, so as to include the latter, until it crosses the southern boundary line, being situated in its entirety on a certain piece of land known as Bien Donn , in the Division of Paarl and measuring as such 280,934 4 morgen.

Certificate of Amended Title on Consolidation 5453/1939, dated 30 May 1939.

Historical Interest

This impressive H-shaped gabled house was built by Dawid de Villiers in 1800.

Historical Interest

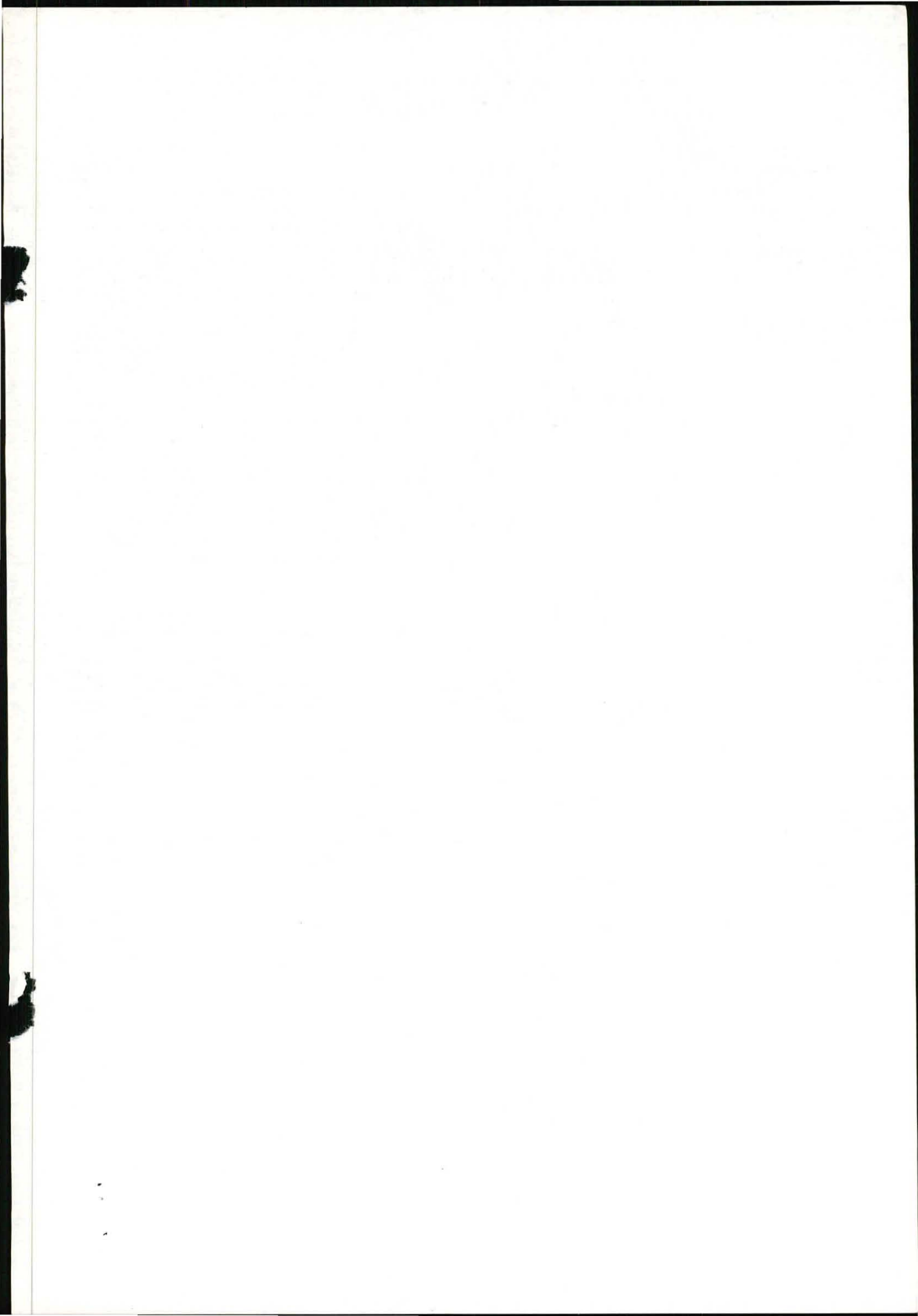

Die plaaswerf met die historiese woonhuis en buitegeboue daarop, omgrens deur die ringmuur, geleë op sekere stuk grond, gedeeltelik vrypag-, gedeeltelik erfpaggrond en gedeeltelik belasbare gebied in die Benede-Eersterivierbesproeiingsdistrik te Faure in die afdeling Stellenbosch, synde die restant van die gekonsolideerde plaas Vergenoegd 653 en groot as sodanig 619,107 3 ha.

Historiese en Argitektoniese Belang

Hierdie eiendom is oorspronklik in 1696 aan Pieter de Vos geëken. Die vroegste gedeelte van hierdie H-vormige woonhuis met sy indrukwekkende gewels, dateer waarskynlik uit die middel van die 18e eeu. Die werf word omgrens deur 'n ringmuur en 'n interessante kompleks buitegeboue.

Wapen.—In blou, 'n galei met seil opgerol en vlieg wapperend, alles van goud, en op 'n skildhoof van goud 'n heraldiese fontein, daaroorheen 'n regopstaande assegaai van natuurlike kleur tussen twee meulsters van swart.

Helmteken.—'n Prinsessekroon van goud met 'n uitkomende takbökkop van natuurlike kleur.

Wronk en dekklede.—Goud en blou.

Wapenspreuk.—PROPE MARE PROPIUSQUE DEUM.

Description

The farmyard with the historic dwelling-house and outbuildings thereon, and bounded by the ring-wall, situate on certain piece of land, partly freehold and partly redeemed quitrent and partly a rateable area in the Lower Eerste River Irrigation District at Faure in the Division of Stellenbosch, being the remainder of the consolidated farm Vergenoegd 653 and measuring as such 619,107 3 ha.

Historical and Architectural Interest

This property was originally granted to Pieter de Vos in 1696. The earliest section of this H-shaped dwelling-house with its impressive gables probably dates from the middle of the 18th century. The farmyard is bounded by a ring-wall and an interesting complex of outbuildings.
