Beskrywing

Die eiendom met die historiese geboue daarop, te Dorpstraat 48-50, en omskryf as sekere stuk eiendomsgrond, geleë in die munisipaliteit en afdeling Stellenbosch, synde restant van Erf 316, Stellenbosch, en groot as sodanig 3 575 vierkante meter. Transportakte 20540/1969, gedateer 1 Augustus 1969.

Historiese en Argitektoniese Belang

Hierdie indrukwekkende argitektoniese kompleks bestaan uit 'n Kaaps-Hollandse huis wat teen 1815 opgerig is en 'n dubbelverdieping-anneks wat uit ongeveer 1860 dateer. Die eiendom het noue verbintnisse met twee bekende Stellenbosse families, naamlik die Neethlings en Ackermans.

Historiese Belang

Hierdie historiese dubbelverdiepinghuise is teen 1841 opgerig as wonings vir Kleurlinge en vrygelate slawe, asook hul afstammeling.

DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the property, with the historic buildings thereon, at 48-50 Dorp Street in Stellenbosch to be a national monument.

Description

The property, with the historic buildings thereon, at 48-50 Dorp Street and described as certain piece of freehold land, situate in the Municipality and Division of Stellenbosch, being Remainder of Erf 316, Stellenbosch, and measuring as such 3 575 square metres. Deed of Transfer 20540/1969, dated 1 August 1969.

Historical and Architectural Interest

This imposing architectural complex consists of a Cape-Dutch house which was erected in about 1815 and a double-storeyed annex which dates back to about 1860. The property is closely associated with two well-known Stellenbosch families, i.e. the Neethlings and Ackermans.

DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the property, known as 37, 39 and 41 Herte Street, Stellenbosch, to be a national monument.

Description

This property, with the historic buildings thereon, at 37, 39 and 41 Herte Street, Stellenbosch, and described as a certain piece of land situate in the Municipality and Division of Stellenbosch, being Erf 591, Stellenbosch, and measuring as such 624 square metres. Deed of Transfer 19344/1972, dated 14 August 1974.

Historical Interest

These historic double-storeyed houses were erected in about 1841 as residences for Coloured people and freed slaves and their descendants.
