Beskrywing

Die hele eiendom bekend as Mayville, dit wil sê die erf waarop die historiese gebou geleë is sowel as die aangrensende erf, en beskryf as sekere stuk grond geleë in die munisipaliteit en afdeling Swellendam, synde Mayville, wat die deel van die Drosdy vorm (nou bekend as die restant van Erf 1126, Swellendam).

Groot 3 616 vierkante meter, volgens die Sertifikaat van Resterende Gedeelte 32/1972, wat deur die kantoor van die Landmetergeneraal, Kaapstad, verskaf is.

Transportaktes 6828/1928 en 6829/1928, gedateer 11 Julie 1928.

Historiese Belang

DECLARATION OF A NATIONAL MONUMENT

Under section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the property known as Mayville, in Swellendam, to be a national monument.

Description

The whole property known as Mayville, that is the plot on which the historical building is situated as well as the adjoining plot, and described as certain land situate in the Municipality and Division of Swellendam, being Mayville, forming part of the Drosty (now known as the remainder of Erf 1126, Swellendam).

Measuring 3 616 square metres, according to the Certificate of Remaining Extent 32/1972, issued by the office of the Surveyor-General, Cape Town.

Deeds of Transfer 6828/1928 and 6829/1928, dated 11 July 1928.

Historical Interest

This property is situated on land which originally formed part of the historical Drosty complex in Swellendam. The house was built about 1853 for the owner, Daniël de Bruyn.
