DECLARATION OF THE BRANDY STILL ON THE FARM SCHOONDERZICHT, DISTRICT OF TULBAGH

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Pieter Gerhardus Jacobus Koornhof, Minister of National Education, hereby declare the historic brandy still situated on the farmyard of Schoonderzicht, in the District of Tulbagh, to be a national monument.

*Description*

The historic brandy still on the farm Schoonderzicht, described as—

(1) certain freehold land, situate in the Division of Tulbagh, being Farm 185, and measuring two comma three five five five (2,355 5) hectares;

(2) certain redeemed quitrent land, situate as above, being Farm 184, and measuring eighteen comma nine three nine three (18,939 3) hectares; and

(3) certain redeemed quitrent land, being Portion 3 (portion of Portion 1) of the farm Witzenberg 182, situate as above, and measuring fourteen comma eight four three seven (14,843 7) hectares.
