DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare Erf 183 with the historic gabled house thereon, at 34 Church Street, as well as Erven 74 and 93, in Tulbagh, to be national monuments.

*Description*

The historic properties in Church Street, Tulbagh, which may be described as follows:

- (i) Certain piece of land with the historic dwelling-house thereon, situate in the Municipality and Division of Tulbagh, being Erf 183, Tulbagh, and measuring 375 (three hundred and seventy-five) square metres;
- (ii) certain piece of land, situate as above, being the remainder of Erf 93, Tulbagh, and measuring, as per remainder, 441 (four hundred and forty-one) square metres; and
- (iii) certain piece of land, situate as above, being the remainder of Erf 74 and measuring, as per remainder, 490 (four hundred and ninety) square metres.

Deed of Transfer 16719/1970, dated 16 June 1970 (paragraphs 1, 2 and 3).

*Historical and Architectural Interest*

The U-shaped Cape-Dutch house on this property was erected in about 1800 and has a concavo-convex gable in front. The erven form an important part of the street scene of the historic Church Street in Tulbagh.

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Johannes Petrus van der Spuy, Minister van Nasionale Opvoeding, hierby Erf 183 met die historiese gewelhuus daarop, te Kerkstraat 34, asook Erwe 74 en 93, in Tulbagh, tot nasionale gedenkwaardighede.

*Beskrywing*

Die historiese eiendomme in Kerkstraat, Tulbagh, wat as volg beskryf word:

- (1) Sekere stuk grond met die historiese woonhuis daarop, geleë in die munisipaliteit en afdeling Tulbagh, synde Erf 183, Tulbagh, en groot 375 (driehonderd vyf-en-sewentig) vierkante meter;
- (ii) sekere stuk grond, geleë soos hierbo, synde die res'tant van Erf 93, Tulbagh, en groot, volgens restant, 441 (vierhonderd een-en-veertig) vierkante meter; en
- (iii) sekere stuk grond, geleë soos hierbo, synde die restant van Erf 74 en groot, volgens restant, 490 (vierhonderd-en-negentig) vierkante meter.
