DECLARATION OF WAVE CREST, KALK BAY

By virtue of the powers vested in me by section 10 (1) of the War Graves and National Monuments Act, 1969 (Act 28 of 1969), I, Gerrit van Niekerk Viljoen, Minister of National Education, hereby declare the house known as Wave Crest, as well as the erf on which it is situated, at Kalk Bay, to be a national monument.

*Description*

The house known as Wave Crest, situated on certain piece of land situate in the City of Cape Town, Cape Division, being the Remainder of Erf 90032, Cape Town, at Kalk Bay, and measuring seven hundred and seventy (770) square metres, including the passage.

Title Deed 1401/1979, dated 4 January 1979.

*Historical and architectural interest*

This residence was built up from two of the earliest cottages in Kalk Bay, the first of which was erected in 1846. The two cottages were joined and Victorianised in about 1890 and a second floor and veranda were added later. The house shows an interesting combination of Georgian and Victorian features. 10/2/957.

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Oorlogsgrafe en Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Gerrit van Niekerk Viljoen, Minister van Nasionale Opvoeding, hierby die woning, bekend as Wave Crest, sowel as die erf waarop dit geleë is, te Kalkbaai, tot nasionale gedenkwaardigheid.

*Beskrywing*

Die huis bekend as Wave Crest, geleë op sekere stuk grond geleë in die stad Kaapstad, Kaapse Afdeling, synde die Restant van Erf 90032, Kaapstad, te Kalkbaai, en groot sewehonderd-en-sewentig (770) vierkante meter, insluitende die gang.

Transportakte 1401/1979, gedateer 4 Januarie 1979.

*Historiese en argitektoniese belang*

Hierdie woning is opgebou uit twee van die eerste huise in Kalkbaai, waarvan een reeds in 1846 opgerig is. Dit is omstreeks 1890 aaneengeskakel en gevictorianiseer en 'n tweede verdieping en veranda is later aangebou. Die huis toon 'n interessante kombinasie van Georgiaanse en Victoriaanse kenmerke. 10/2/957.
