Colours (Uniform).—On a cream background vertical royal blue stripes each $\frac{1}{8}$ inch wide and $2\frac{1}{2}$ inches apart: varied for (a) the jersey, to horizontal royal blue and white stripes each $1\frac{1}{2}$ inch wide and alternating one with the other, (b) for the necktie, diagonal royal blue and white stripes $1\frac{1}{2}$, $\frac{1}{2}$ inch and $\frac{1}{2}$ inch wide, respectively, and (c) for the scarf, horizontal royal blue and white stripes 3 inches and $\frac{1}{2}$ wide, respectively.
Badge.—On a cream background on a shield bordered in royal blue and gold, a representation of a red Disa flower, and the letters and word "W. P. Rugby".
