\* No. 702.] THE NATURAL AND HISTORICAL MONUMENTS, RELICS AND ANTIQUES ACT, 1934.—PROTECTION OF MONUMENTS.

It is hereby notified for general information that the Minister of the Interior has been pleased, under the powers vested in him by section eight of the Natural and Historical Monuments, Relics and Antiques Act, 1934 (Act No. 4 of 1934), to proclaim the objects set out in the Schedule below to be monuments in terms of paragraph (a) of that section.
