In die geval van die kiesafdelings vermeld in die derde en vierde paragraawe hierbo, mag besware soos bo vermeld, voor die sewende dag van September 1937 ingedien word.

It is hereby notified for general information that the Minister of the Interior has been pleased, under the powers vested in him by section *eight* of the Natural and Historical Monuments, Relics and Antiques Act, 1931 (Act No. 4 of 1934), to proclaim the objects set out in the Schedule below to be monuments in terms of paragraph (a) of that section.

**BIENNIAL REGISTRATION OF VOTERS.**

**NOTICE INVITING CLAIMS AND OBJECTIONS.**

Attention is hereby invited to the Alphabetical Provisional Lists of Voters posted at the offices of the various Registering Officers and at other places throughout the Union, and notice is hereby given that if any person whose name is not enrolled on any of the said lists shall claim to be entitled to have his or her name enrolled thereon, then any such person or other person on his or her behalf may, if entitled to registration in any electoral division other than those mentioned below, at any time before the third day of August, 1937, lodge with the Registering Officer or the Registration Assistant of the electoral division or sub-division of the electoral division concerned, either by transmission through the post or in some other manner, his or her claim on the prescribed form to be registered as a voter, in order that such claim may be considered and dealt with as the law directs.

If any person shall object to the enrolment of any other person whose name is included in any of the above-mentioned lists or who may claim to be so included, then every such objector may lodge his or her objection on the prescribed form with the Registering Officer or the Registration Assistant of the electoral division or sub-division of the electoral division concerned before the thirteenth day of August, 1937, in order that such objection may be considered and dealt with as the law directs.

In regard to the electoral divisions of Benoni, Bezuidenhout, Fordsburg, Hospital, Jeppes, Johannesburg (North), Kensington, Langlaagte, Parktown, Rosettenville, Troyeville, Turfontein, Von Brandis, Vrededorp, Yeoville, Boksburg, Boksburg (North), Brakpan, Germiston, Krugersdorp, North Rand, Roodepoort and Springs, the Alphabetical Provisional Lists of Voters will be posted on the fourteenth day of July, 1937, and claims for registration should reach the Registering Officer or Registration Assistant concerned at any time before the thirteenth day of August, 1937.

In regard to the electoral divisions of Durban (Berea), Durban (County), Durban (Greyville), Durban (Point), Durban (Stamford Hill), Durban (Umbilo), Durban (Umlazi), Illovo, Klip Rivier, Natal Coast, Newcastle, Pietermaritzburg (District), Pietermaritzburg (North), Vryheid, Weenen and Zululand, the Alphabetical Provisional List of Voters will be posted on the twelfth day of July, 1937, and claims for registration should reach the Registering Officer or Registration Assistant concerned at any time before the eleventh day of August, 1937.

In the case of the electoral divisions mentioned in the third and fourth paragraphs hereof, objections may be lodged, as stated above, before the seventh day of September, 1937.

Blank forms of claim and objection may be obtained upon application to any Registering Officer or Registration Assistant.
