I, JAN HENDRIK HOFMEYR, Minister of Labour and Social Welfare, acting in pursuance of and subject to the provisions of section *eleven* of the Apprenticeship Act, 1922, as amended, hereby, with effect from the date of this notice, establish for the Magisterial District of Stellenbosch, the Apprenticeship Committee known as the Cape Mechanical and Electrical Engineering Apprenticeship Committee, to advise me in accordance with the said Act on all matters connected with the conditions governing apprenticeship in the Mechanical and Electrical Engineering Industries in the said Magisterial District, in addition to the Magisterial Districts of the Cape, Wynberg, Simonstown and Bellville and the Municipal areas of Paarl, Somerset Strand and Somerset West, together with the area occupied by the Cape Explosives Works, Ltd., Somerset West, in respect of which the said Committee was established by Government Notice No. 988 of 10th July, 1936.

It is hereby notified for general information that the Minister of the Interior has been pleased, under the powers vested in him by section *eight* of the Natural and Historical Monuments, Relics and Antiques Act, 1934 (Act No. 4 of 1934), to proclaim the objects set out in the Schedule below to be monuments in terms of paragraph (a) of that section.

His Excellency the Governor-General has been pleased, in terms of section *one hundred and forty-seven* of the South Africa Act, 1909, and section *ten* (1) of Transvaal Ordinance No. 17 of 1905, to amend regulation No. 6 of the Asiatic Bazaar Regulations of the Municipality of Potchefstroom, as published in Government Notice No. 273 of the 28th February, 1907, by the addition to the first paragraph thereof of the following paragraph:—

“ The local authority may in its discretion enter into leases of lots for periods of three years renewable at the option of the Lessee for further periods of three years, but not to exceed twenty-one years in all, and the rent to be charged in respect of each renewal period of a lease shall be the rental fixed under these regulations, or any amendment thereof, in force at the date of such renewal.”
