DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the historic gateway and gates at the Theological Seminary in Stellenbosch to be a national monument.

Description

The historic gateway and gates at the Theological Seminary, situate on the remainder of Erf 1188, Stellenbosch. Deed of Transfer 140/1853, dated 20 September 1853.

Historical Interest

The gateway and gates which were erected at about 1769 as part of the Drostdy at that time, are situated on the most historic site in Stellenbosch. This site has associations with Simon van der Stel and the respective Drostdy buildings were formerly also situated here until, in 1859, they became the seat of the Theological Seminary.

Description

The property with the historic Old Gaol thereon, situate in the Municipality of Burgersdorp, and Division of Albert, being Erf 102, and measuring 156 square roods 136 square feet.

Deed of Grant 46/1969, dated 7 March 1969.

Historical Interest

This gaol was completed in 1861 and played an important role during the Anglo-Boer War and the Rebellion of 1914.

Historiese Belang

Hierdie poort en hekke wat teen 1769 opgerig is as deel van die destydse Drostdy, is geleë op die mees historiese terrein in Stellenbosch. Hierdie terrein het naamlik assosiasies met Simon van der Stel en die onderskeie Drostdy-geboue was ook vroeër hier geleë totdat dit in 1859 die setel van die Teologiese Kweekskool geword het.
