DECLARATION OF A NATIONAL MONUMENT

Under section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the property, known as the Worcester Museum, on Erf 811, Worcester, to be a national monument.

Description

Certain piece of land with the building thereon, being Erf 811, Worcester, situate in the Municipality and Division of Worcester, measuring 98 square rods 63,31 square feet and held under Deed of Transfer 15342/1963, dated 1 October 1963.

Architectural Interest

This building is a typical example of the mid-nineteenth century architecture in Worcester. The house was built in 1841 and had been the property of the well-known Beck family for many years.

Beskrywing

Sekere stuk grond met die gebou daarop, synde Erf 811, Worcester, geleë in die munisipaliteit en afdeling Worcester, groot 98 vierkante roede 63,31 vierkante voet en gehou kragtens Transportakte 15342/1963, gedateer 1 Oktober 1963.

Argitektoniese Belang

Hierdie gebou is 'n tipiese voorbeeld van die middel-negentiende-eeuse argitektuur in Worcester. Die huis is in 1841 opgerig en was vir baie jare die eiendom van die bekende Beck-familie.

This building is a typical example of the mid-nineteenth century architecture in Worcester.

DECLARATION OF A

Under section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the property, known as the Fort Hendrina, on the corner of Erasmus and Hendrina Streets, Worcester, to be a national monument.

Fort Hendrina, situate on the corner of Erasmus and Hendrina Streets, Worcester, is the only example of a movable iron fort in the Transvaal.

DECLARATION OF A

Under section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the property, known as the Bergville Blockhouse, on the corner of Waterval and Bergville Streets, Bergville, Natal, to be a national monument.

A certain blockhouse situate on the corner of Waterval and Bergville Streets, Bergville, Natal, measuring 47,31 square rods 47,31 square feet and held under Deed of Transfer 15342/1895, dated 1 October 1895.

This blockhouse was built during the Anglo-Boer War (1899-1902) and served as a link in the chain of defence against the incursions of Boer guerrillas. It is the only known blockhouse of its kind in Natal.
