DESCRIPTION.

Krugerhof, Waterval-Onder: The figure ABCDEF represents the Krugerhof area on a portion of the farm Doornhoek, No. 341 J. T. situated in the District of Belfast, Province of the Transvaal, as indicated in Diagram S.G. No. A.769/62, dated 4th April, 1962.

HISTORICAL INTEREST.

President S. J. P. Kruger lived in this house from the 30th June, to the 28th August, 1900. During that time the affairs of State of the South African Republic were conducted there.
