PROCLAMATION OF A MONUMENT.

By virtue of the powers vested in me by paragraph (a) of sub-section (1) of section eight of the Natural and Historical Monuments, Relics and Antiques Act, 1934 (Act No. 4 of 1934), as amended, I hereby proclaim the old Nederlandsche Zuid Afrikaansche Spoorweg Maatschappij tunnel, Waterval-Boven, to be a monument.

DESCRIPTION.

Tunnel, Waterval-Boven, on Portion 105 of the farm Doornhoek No. 344—J.T., situate in the District of Carolina, Province of the Transvaal, as shown on Diagram No. A.5294/61.

HISTORICAL INTEREST.

The tunnel was part of the N.Z.A.S.M. railway line built in 1891-1895 between Pretoria and Lourenco Marques. In view of the steep gradient it was fitted with a rack railway.
