By virtue of the powers vested in the South African Heritage Resources Agency (SAHRA) in terms of Section 27 (5) of the National Heritage Resources Act, no 25 of 1999, SAHRA hereby declares the **PARLIAMENT OF SOUTH AFRICA A NATIONAL HERITAGE SITE**.

SIGNIFICANCE

The **PARLIAMENT OF SOUTH AFRICA** and **PARLIAMENTARY PRECINCT, ERF 95165; ERF 95164; STAL PLEIN ERF 3741; ERF 9557; ERF 3789; ERF 3790; ERF 3794 AND ERF 3798** is located in a precinct defined by Plein Street and Government Lane, stretching in extent from the corner of Adderley Street to the southernmost part of the Company Gardens.

On assessment, the significance of the property is understood as having **Historical value, Aesthetic value, Scientific value, Social value** and, exhibits **Rarity qualities** and qualities that speak a universal language, that of **Representivity**.
