**DECLARATION OF A NATIONAL MONUMENT**

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare a portion of the historical Bloodriver Battlefield in the District of Utrecht to be a national monument.

**Description**

The portion of the Township of Blood River, situated on the remainder of Charl Cilliers of A of Vechtkop 168, District of Utrecht, Natal, as defined below:
